In a deal that closed Friday, McDonnell Douglas Field Services Co. will be renamed Novadyne Computer Systems Co.

NOVADYNE COMPUTER SYSTEMS INC HAS ADDED AN ON-LINE SYSTEM DIAGNOSTICS AND DISK UTILITY TO ITS REALITY PICK LINE

Novadyne Computer Systems Inc, the Santa Ana, California successor company to McDonnell Douglas Information Systems in North America, has added an on-line system diagnostics and disk utility to provide transparent, remote disk error correction for its Reality Pick line: the System On-Line Maintenance Executive enables its service engineers to ensure proper disk and media function without an on-site visit or the system being taken down - when the Novadyne engineer invokes the thing, remotely via modem, it suspends all on-going operations of the Reality system for less than 500mS and while the computer is in sleep mode, defective media - the primary cause of disk errors - are reassigned automatically, the company explains.
